WEDNESDAY, SEPTEMBER 6, 2023

The House of Delegates was called to order at 10:00 a.m. by C. Todd Gilbert, Speaker thereof.

The Mace was placed on the Speaker's table by the Sergeant at Arms.

At the request of Delegate Wyatt, the Reverend Chris Santasiere of Fairmount Christian Church, Mechanicsville, offered the prayer.

Delegate Kilgore led the House of Delegates in the Pledge of Allegiance to the Flag of the United States of America.

The Clerk made the following remarks, relating to the results of the Special Election for member of the 6th House of Delegates district:

Members, please be advised that pursuant to Article IV, Section 7 of the Virginia Constitution providing that the House of Delegates "shall judge of the election, qualification, and returns of its members," and at the direction of the Speaker of the House of Delegates, I am pleased to report the following:

In the special election, called by the Governor, to fill the vacancy in the 6th House of Delegates district, which occurred on Tuesday, August 29, 2023, it has been determined that Jonathan E. "Jed" Arnold received a majority of the votes cast and was duly sworn into office on September 5, 2023.

Delegate March, pursuant to House Rule 4, was granted approval by the Speaker to participate via electronic communication means.

A quorum being present, the House proceeded with the business of the day.

The Speaker granted leaves of absence to Delegates Edmunds, Kory, Murphy, Ward, and Ware, who were absent from the session of the House today on account of pressing personal business.

The Speaker stated that the purpose of this Special Session of the General Assembly was delineated in a Proclamation issued by the Governor, reading as follows:

COMMONWEALTH OF VIRGINIA
Executive Department

Proclamation

In accordance with the provisions of Article IV, Section 6, and Article V, Section 5, of the Constitution of Virginia and the powers thereby vested in the Governor to call a Special Session of the General Assembly,

I, Glenn Youngkin, Governor of Virginia, do hereby summon the members of the Senate and the House of Delegates, constituting the General Assembly of Virginia, to meet in Special Session commencing at 10:00 AM on the 6th day of September, two thousand and twenty-three for the purpose of the completion of amendments to the 2023-2024 biennial budget.

Given under my hand as Governor of Virginia, and under the Lesser Seal of the Commonwealth, at Richmond, this 29th day of August, two thousand and twenty-three, and in the two hundred and forty-eighth year of the Commonwealth.

Delegate Kilgore offered the following House joint resolution:

HOUSE JOINT RESOLUTION NO. 6001

Limiting legislation to be considered by the 2023 Special Session I of the General Assembly and establishing a schedule for the conduct of business coming before such Special Session.

RESOLVED by the House of Delegates, the Senate concurring, That during the 2023 Special Session I of the General Assembly, summoned by proclamation of the Governor on Tuesday, August 29, 2023 to begin Wednesday, September 6, 2023 at 10:00 AM, except with the unanimous consent of the house in which the legislation is offered, no bill, joint resolution, or resolution shall be offered or considered in either house during the Special Session other than (i) a Budget Bill; (ii) single-house commending resolutions; or (iii) bills, joint resolutions, or resolutions affecting the rules of procedure or schedule of business of the General Assembly, either of its houses, or any of its committees; and, be it

RESOLVED FURTHER, That after the Special Session is convened for the first time, each body may adjourn from time-to-time until reconvened with at least 48 hours' notice by the respective call of the Speaker of the House of Delegates and the Chair of the Senate Committee on Rules; and, be it

RESOLVED FURTHER, That for purposes of this resolution:

"Budget Bill" means a general appropriation bill introduced in each house that authorizes or commits the expenditure of public revenues during the Commonwealth's fiscal year ending June 30, 2024; and, be it

RESOLVED FURTHER, That the failure of the General Assembly to act on an appointment made by the Joint Committee on Rules to the Board of Trustees of the Virginia Retirement System at the 2023 Regular Session of the General Assembly or at this subsequent special session, shall not be deemed to be a failure to confirm any such appointment and shall not render any such appointee ineligible for reappointment at the next regular session of the General Assembly.

RESOLVED FINALLY, That the 2023 Special Session I of the General Assembly shall be governed by the following procedural rules:

Rule 1. Neither house shall receive, consider, or vote on any committee amendment, floor amendment or amendment of the other house to the Budget Bill. No engrossment of the Budget Bill shall be required in either house.

Rule 2. Neither house shall consider such Budget Bill earlier than 48 hours after introduction, unless both houses respectively determine to proceed earlier by a vote of two-thirds of the members voting in each house. A report shall be issued concurrently with the introduction of the Budget Bill that identifies the following by item number, narrative description, and dollar amount: (i) any item in the Budget Bill that was not included in a general appropriation bill as passed by either the House or the Senate during the 2023 Regular Session and (ii) any item that represents legislation that failed in either house during the 2023 Regular Session.

Delegate Roem propounded a parliamentary inquiry as to whether the resolution established the rules for the Session and whether it included a rule which prevented the members from filing objections or floor amendments to the Budget Bill.

The Speaker stated that the Delegate was correct.

The joint resolution was agreed to.

Delegate Knight offered the following House resolution:

HOUSE RESOLUTION NO. 639

Salaries, contingent and incidental expenses; per diem payment during Special Session I.

RESOLVED by the House of Delegates, That the Comptroller is directed to issue his warrants on the Treasurer, payable from the contingent fund of the House to accomplish the work of the House of Delegates during the 2023 Special Session I of the General Assembly. Necessary payments to cover salaries of temporary employees, as well as contingent and incidental expenses, will be certified by the Clerk or his designee; and, be it

RESOLVED FINALLY, That members of the House of Delegates shall receive session per diem for any day they attend a scheduled floor session at which an attendance roll call is taken. Session per diem shall not be allowed for legislative assistants. Session per diem shall not be allowed for members of the House of Delegates during a recess of the special session. However, members may receive compensation while the House of Delegates is in recess, as provided in § 30-19.12 of the Code of Virginia, as follows: (i) members of any standing committee; (ii) members of any committee of conference; or (iii) members of any legislative committee, commission, or council established by the General Assembly.



The "Bills and Resolutions" category provides a breakdown of Journal day entries that encompasses the legislative process from introduction to enactment. The "Motions and Requests" category is a breakdown of every motion made by a member or every request for action allowed pursuant to member privilege. Parliamentary inquiries and points of order are set out in the Subject Index under those specific categories and noted by member. The Speaker's statements and rulings are found under "Speaker of the House of Delegates [C. Todd Gilbert]."

The **Numerical Index** is a list of bills and resolutions in numerical order with entries that provides Journal page number references to specific legislative actions that occurred on the House floor. This Index is useful in tracking an identified piece of legislation from introduction to final disposition.
