## FOREWORD

This Final Cumulative Index includes bills, joint resolutions, and resolutions, introduced for the 2013 Special Session I of the General Assembly of the Commonwealth of Virginia, which convened April 3, 2013. The General Assembly adjourned sine die April 4, 2013, reconvened May 15, 2013, pursuant to Section 6 of Article IV of the Constitution of Virginia, and adjourned sine die May 15, 2013.

Legislative measures are indexed by subject, showing bill numbers, code sections, and chief patrons. The chapter numbers assigned for the *2013 Special Session I Acts of Assembly* are also included.

Also included is a Patron Report, listing Delegates and Senators with the bills and resolutions they patron and co-patron, a Bill and Resolution Status Report containing the legislative history on all bills and resolutions, and the Acts of Assembly Chapter Report, which lists legislative measures by the chapter numbers assigned for the *2013 Special Session I Acts of Assembly*.
